Mayor Wills asked for a motion to approve the Revised Accounts Payables for February 3, 2025, in the amount of \$215,975.89. Mayor Pro Tempore Phillips moved to approve the Revised Accounts Payables. The motion was seconded by Councilmember Franklin, and the motion unanimously carried.

Mayor Wills asked for a motion to approve a proclamation for Arbor Week for February 16 through February 22, 2025, with Arbor Day being on February 22, 2025. Councilmember Clemmons moved to approve the Proclamation. The motion was seconded by Councilmember Taylor, and the motion unanimously carried. Consideration of Ordinance on First Reading

Mayor Wills asked for a motion to approve Ordinance 1056 Regarding the Salary of the Mayor and City Councilmembers including Ordinances: 653, 717, 763, 806, 941, 971, 972, 989, 990 and to Establish the Salary of the Mayor and City Councilmembers. Councilmember Franklin moved to approve Ordinance 1056 on first reading. The motion was seconded by Councilmember Taylor, and the motion unanimously carried.

Consideration of Resolutions

Mayor Wills asked for a motion to approve Resolution 0225-01 Fee Waiver for the North Baldwin Chamber of Commerce Annual Events. Councilmember Clemmons moved to approve Resolution 0225-01. The motion was seconded by Councilmember Franklin, and the motion unanimously carried.

Mayor Wills asked for a motion to approve Resolution 0225-02 appropriation to the North Baldwin Literacy Council. Councilmember Sellers moved to approve Resolution 0225-02 appropriating \$1,500 to the North Baldwin Literacy Council with funds being expended from contingency funds as follows: Mayor-\$250; District 1-\$250; District 2-\$250;District 3-\$250; District 4-\$250; and District 5-\$250. The motion was seconded by Mayor Pro Tempore Phillips, and the motion unanimously carried.
