THE MINUTES OF THE REGULAR MEETING OF THE CITY COUNCIL OF THE CITY OF BAY MINETTE, ALABAMA AS HELD OCTOBER 7, 2013

The regular called meeting of the City Council of the City of Bay Minette was held October 7, 2013 at 6:00 p.m. at the City Hall in Bay Minette, Alabama; this being the proper place, date and hour for holding such meeting.

On roll call, the following members of Council were found to be present: Mayor Robert A. Wills; Councilmember Danleigh Corbett; Councilmember Kathy Dobbins, Councilmember John Biggs, Councilmember Dollie Mims and Councilmember Chris Norman. Mayor Wills called the meeting to order and gave the invocation. Councilmember Mims led the pledge of allegiance.

Councilmember Corbett moved to approve Resolution 1013-01. The motion was seconded by Councilmember Biggs and unanimously carried.

Mayor Wills asked for a motion to approve Resolution 1013-02 confirming the Appointment of Certain Municipal Non-Elected Public Officials; Gloria May as Court Magistrate. Councilmember Mims moved to approve Resolution 1013-02. The motion was seconded by Councilmember Corbett and unanimously carried.
