Mayor Wills called the meeting to order and Chief Crook gave the invocation. Councilman Mims led the pledge of allegiance.

Mayor Wills asked for a motion to approve the Consent Agenda which included the following items: Item A: Approve Minutes of October 6, 2014 City Council Meeting and Work Session. Item B: Monthly Reports. Councilmember Corbett moved to approve the consent agenda. The motion was seconded by Councilmember Norman and unanimously carried.

The Report of Finance Committees and Board/Commissions included the following: Mayor Wills asked for a motion to approve the payables in the amount of \$133,226.27. Councilmember Dobbins moved to approve the payables. The motion was seconded by Councilmember Mims and unanimously carried.

Mayor Wills asked for a motion to approve Robbie Strom's appointment to the Bay Minette Planning Commission to replace Al Thompson. Councilmember Corbett moved to approve the appointment. The motion was seconded by Councilmember Dobbins and unanimously carried.

Mayor Wills asked for a motion to approve Resolution Number 1014-03 authorizing the Mayor to execute contract in regards to Employee's health insurance. Councilmember Corbett

moved to approve the resolution. The motion was seconded by Councilmember Mims and unanimously carried.

Councilmember Biggs moved to expend \$500 from District 3 Council contingency fund to the Bay Minette Intermediate School for improvements at the school and the music program. The motion was seconded by Councilmember Mims and unanimously carried.

Councilmember Biggs moved to expend \$110 from District 3 Council contingency fund to the street department of signs. The motion was seconded by Councilmember Dobbins and unanimously carried.
