Others in attendance were: Rita Findley, City Clerk; Joe Landenwich, Finance Director; Tina Covington, Community Relations Coordinator; Clarence Crook, Police Chief; Mike Minchew, Fire Chief; Trey Dickson, Court Clerk/Magistrate and Scotty Lewis, City Attorney.

Mayor Wills called the meeting to order and gave the invocation. Councilman Dobbins led the pledge of allegiance.
