The regular called meeting of the City Council of the City of Bay Minette was held February 19, 2015 at 6:00 p.m. at the City Hall in Bay Minette, Alabama; this being the proper place, date and hour for holding such meeting.

On roll call, the following members of Council were found to be present: Mayor Wills, Councilmember Danleigh Corbett; Councilmember John Biggs, Councilmember Dollie Mims and Councilmember Chris Norman. Others in attendance were: Laura Strachen, sitting in for the City Attorney; Joe Landenwich, Finance Director; Tina Covington, Public Relations Coordinator; Clarence Crook, Police Chief; Mike Minchew, Fire Chief; Trey Dickson, Court Magistrate; Lamar Hadley, Public Works.

Mayor Wills called the meeting to order and Chief Crook gave the invocation. Councilmember Mims led the pledge of allegiance.

Mayor Wills recognized Isabella Eleogo from Bay Minette Middle School for winning the Baldwin County Spelling Bee.

Mayor Wills asked for a motion to approve the Consent Agenda which included the following items: Item A: Approve Minutes of the February 2, 2015 City Council Meeting and Work Session.
