The regular called meeting of the City Council of the City of Bay Minette was held March 2, 2015 at 6:00 p.m. at the City Hall in Bay Minette, Alabama; this being the proper place, date and hour for holding such meeting.

On roll call, the following members of Council were found to be present: Mayor Wills, Councilmember Danleigh Corbett; Councilmember John Biggs, Councilmember Dollie Mims and Councilmember Chris Norman. Mayor Wills called the meeting to order and gave the invocation. Councilmember Norman led the pledge of allegiance.
