THE MINUTES OF THE REGULAR MEETING OF THE CITY COUNCIL OF THE CITY OF BAY MINETTE, ALABAMA AS HELD SEPTEMBER 19, 2016

The regular called meeting of the City Council of the City of Bay Minette was held September 19, 2016 at 6:00 p.m. at the City Hall in Bay Minette, Alabama; this being the proper place, date and hour for holding such meeting.

On roll call, the following members of Council were found to be present: Mayor Robert A. Wills; Councilmember Danleigh Corbett; Councilmember Kathy Dobbins; Councilmember John Biggs; Councilmember Dollie Mims and Councilmember Chris Norman. Mayor Wills called the meeting to order and gave the invocation. Councilmember Norman led the Pledge of Allegiance.

Mayor Wills asked for a motion to approve the Consent Agenda. Councilmember Mims moved to approve Resolution Number 0916-13. The motion was seconded by Councilmember Norman and unanimously carried.
