The regular called meeting of the City Council of the City of Bay Minette was held December 5, 2016 at 6:00 p.m. at the City Hall in Bay Minette, Alabama; this being the proper place, date and hour for holding such meeting.

On roll call, the following members of Council were found to be present: Mayor Robert A. Wills; Councilmember Danleigh Corbett; Councilmember Mike Phillips; Councilmember John Biggs; Councilmember William Taylor; and Councilmember Shannon Clemmons. Mayor Wills called the meeting to order and Mr. Bower gave the invocation. Councilmember Corbett led the Pledge of Allegiance.

Councilmember Corbett moved to consider Ordinance 976 on one reading. The motion was seconded by Councilmember Phillips and unanimously carried. Councilmember Corbett moved to approve Ordinance 976. The motion was seconded by Councilmember Taylor and unanimously carried.

Mayor Wills asked for a motion to expend contingency funds to the Baldwin County Department of Archives and History to assist with moving the Little Red School House to the Baldwin County Bicentennial Park. Contingency expenditures are as follows: Mayor Wills- \$100; District 1-\$100; District 2-\$100; District 3-\$500; District 4-\$100 and District 5-\$100. Councilmember Clemmons moved to approve the expenditure of Contingency Funds. The motion was seconded by Councilmember Taylor and unanimously carried.

Mayor Wills announced Christmas Fest to be held on December 9 and 10, 2016.

Mayor Wills asked for any comments from the public. Mr. Larry Naves addressed the Council concerning the lights at Ulmer Park on the basketball courts and asked that they be repaired.

There being no further business, Mayor Wills asked for a motion to adjourn the City Council Meeting. Councilmember Phillips moved to adjourn the meeting. The motion was seconded by Councilmember Taylor and unanimously carried.
