THE MINUTES OF THE REGULAR MEETING OF THE CITY COUNCIL OF THE CITY OF BAY MINETTE, ALABAMA AS HELD JULY 16, 2018

The regular called meeting of the City Council of the City of Bay Minette was July 16, 2018 at 6:00 p.m. at the City Hall in Bay Minette, Alabama; this being the proper place, scheduled date and hour for holding such meeting.

On roll call, the following members of Council were found to be present: Mayor Robert A. Wills; Councilmember Danleigh Corbett; Councilmember Mike Phillips; Councilmember John Biggs; Councilmember William Taylor and Councilmember Shannon Clemmons. Mayor Wills called the meeting to order and Councilmember Taylor gave the invocation. Councilmember Biggs led the Pledge of Allegiance.

Mayor Wills asked for a motion to approve the consent agenda. Item A: Approve Minutes of July 3, 2018 City Council Meeting. Councilmember Corbett moved to approve the Consent Agenda. The motion was seconded by Councilmember Taylor and unanimously carried.

Councilmember Biggs moved to approve the Resolution. The motion was seconded by Councilmember Taylor and unanimously carried.

Councilmember Corbett moved to approve the Resolution. The motion was seconded by Councilmember Biggs and unanimously carried.

Mayor Wills asked for a motion to approve Resolution Number 0718-04 Ground Lease Agreement between City of Bay Minette and North Baldwin Chamber of Commerce. Councilmember Phillips moved to approve the Resolution. The motion was seconded by Councilmember Corbett and unanimously carried.

Mayor Wills asked for a motion to approve Resolution Number 0718-05 Consulting Agreement between City of Bay Minette and Cobbs, Allen and Hall. Councilmember Biggs moved to approve the Resolution. The motion was seconded by Councilmember Corbett and unanimously carried.

Mayor Wills recognized Chief Minchew for his suggestion of the Public Safety Event which was a huge success.
