## THE MINUTES OF THE REGULAR MEETING OF THE CITY COUNCIL OF THE CITY OF BAY MINETTE, ALABAMA AS HELD AUGUST 17, 2020

The regular called meeting of the City Council of the City of Bay Minette was held on August 17, 2020 at 6:00 p.m. at the City Hall in Bay Minette, Alabama; this being the proper place, scheduled date and hour for holding such meeting.

On roll call, the following members of Council were found to be present: Mayor Robert A. Mayor Wills called the meeting to order and gave the invocation. Councilmember Phillips led the Pledge of Allegiance.

## Consent Agenda

Mayor Wills asked for a motion to approve the consent agenda. Councilmember Taylor moved to approve the consent agenda. The motion was seconded by Councilmember Corbett and unanimously carried.

Councilmember Biggs moved to approve the resolution. The motion was seconded by Councilmember Clemmons and unanimously carried.

Mayor Wills asked for a motion to approve Resolution Number 0820-17 Tigers Banners appropriating \$3,240 from the following contingencies: Mayor's-\$1,000; District 1-\$500; District 3-\$740; District 4-\$500 and District 5-\$500. Councilmember Clemmons moved to approve the resolution. The motion was seconded by Councilmember Phillips and unanimously carried.

Mayor Wills asked for a motion to approve Resolution Number 0820-18 Beautification Committee Project appropriating \$3,111.84 from the following contingencies: Mayor's-\$1,000; District 1-\$500; District 2-\$361.84; District 3-\$500; District 4-\$250 and District 5-\$500. Councilmember Biggs moved to approve the resolution. The motion was seconded by Councilmember Phillips and unanimously carried.
