THE MINUTES OF THE REGULAR CALLED MEETING OF THE CITY COUNCIL OF THE CITY OF BAY MINETTE, ALABAMA AS HELD SEPTEMBER 21, 2020

The regular meeting of the City Council of the City of Bay Minette was held on September 21, 2020 at 6p.m. at the City Hall in Bay Minette, Alabama; this being the proper place, scheduled date and hour for holding such meeting.

On roll call, the following members of Council were found to be present: Mayor Robert A. Wills; Councilmember Anne Corbett; Councilmember John Biggs; Councilmember Mike Phillips; and Councilmember William. Taylor; Councilmember Shannon Clemmons was absent. Others in regular attendance: Scotty Lewis, Stone-Crosby, PC; Tammy Smith, City Administrator/Finance Director; Rita Diedtrich, City Clerk; Tina Covington, Community Relations Coordinator; Clair Dorough and Jessica Peed, Planning and Development; Al Tolbert, Police Chief; Joseph Hall, Superintendent Grounds, Parks, Custodial and Recreation; Jason Padgett, NBU; . Mayor Wills called the meeting to order and gave the invocation. Councilmember Corbett led the Pledge of Allegiance.

Mayor Wills asked for a motion to approve a Proclamation for "Family Day". Councilmember Corbett moved to approve the proclamation. The proclamation was seconded by Councilmember Taylor and unanimously carried.

Mayor Wills recognized Kyle with American Red Cross who encouraged community involvement.

Consent Agenda

Mayor Wills asked for a motion to approve Resolution Number 0920-19 North Baldwin Literacy Council expending \$500.00 from District 3 Council Contingency, \$345.89 from District 4 Council Contingency and \$1,500.00 from the Mayor's Contingency. Councilmember Biggs moved to approve the resolution. The motion was seconded by Councilmember Corbett and unanimously carried.

Mayor Wills asked for a motion to approve Resolution Number 0920-20 Baldwin County High School expending \$1,000.00 from the Mayor's Contingency. Councilmember Biggs moved to approve the resolution. The motion was seconded by Councilmember Phillips and unanimously carried.

Mayor Wills asked for a motion to approve Resolution Number 0920-21 Area Women's Action Group expending \$500.00 from District 4 Council Contingency. Councilmember Biggs moved to approve the resolution. The motion was seconded by Councilmember Taylor and unanimously carried.

Mayor Wills asked for a motion to approve Resolution Number 0920-22 Amending Permit Fees for Re-Roofing due to damage from Hurricane Sally from \$80.00 to a straight \$25.00 with no

application fee for a period of six months from September 15, 2020. Councilmember Corbett moved to approve the resolution. The motion was seconded by Councilmember Phillips and unanimously carried.

Mayor Wills extending best wishes to the family of former Councilmember John Cox and acknowledged his years of service to the City of Bay Minette.
