## THE MINUTES OF THE REGULAR CALLED MEETING OF THE CITY COUNCIL OF THE CITY OF BAY MINETTE, ALABAMA AS HELD MAY 17, 2021

The regular meeting of the City Council of the City of Bay Minette was held on May 17, 2021 at 6 p.m. at the City Hall in Bay Minette, Alabama; this being the proper place, scheduled date and hour for holding such meeting.

On roll call, the following members of the Council were found to be present: Mayor Robert A. Wills; Councilmember Pete Sellers; Councilmember Mike Phillips; Councilmember Matt Franklin; Councilmember William Taylor and Councilmember Shannon Clemmons. Mayor Wills called the meeting to order and gave the invocation. Councilmember Franklin led the Pledge of Allegiance.

## Consent Agenda

Mayor Wills asked for a motion to approve the consent agenda. Item A: Approve Minutes of May 3, 2021 City Council Meeting and Work Session. Councilmember Taylor moved to approve the consent agenda. The motion was seconded by Councilmember Franklin and unanimously carried.

Mayor Wills asked for a motion to approve Resolution Number 0521-05 Agreement between PursuitAlert, LLC and the City of Bay Minette. Councilmember Clemmons moved to approve the Resolution. The motion was seconded by Councilmember Sellers and unanimously carried.

Mayor Wills asked for motion to approve Resolution Number 0521-06 Confirming the Appointment of Certain Municipal Non-Elected Public Official—Building Official, Robert Madison. Councilmember Taylor moved to approve the Resolution. The motion was seconded by Councilmember Franklin and unanimously carried.

Mayor Wills asked for motion to approve Resolution Number 0521-07 Bay Minette Recreation Department Softball Program with 8U and 10U All Star Teams. Councilmember Clemmons moved to approve the Resolution with appropriations being expended as follows: Mayor's Contingency-\$356; District 1 Contingency-\$300; District 2 Contingency-\$300; District 3 Contingency-\$300; District 4 Contingency-\$300 and District 5 Contingency-\$300. The motion was seconded by Councilmember Taylor and unanimously carried.
