## THE MINUTES OF THE REGULAR CALLED MEETING OF THE CITY COUNCIL OF THE CITY OF BAY MINETTE, ALABAMA AS HELD MARCH 21, 2022

The regular meeting of the City Council of the City of Bay Minette was held on March 21, 2022, at 6 p.m. at the City Hall in Bay Minette, Alabama; this being the proper place, scheduled date and hour for holding such meeting.

On roll call, the following members of the Council were found to be present: Mayor Robert A. ## Consent Agenda
