THE MINUTES OF THE REGULAR CALLED MEETING OF THE CITY COUNCIL OF THE CITY OF BAY MINETTE, ALABAMA AS HELD NOVEMBER 7, 2022

The regular meeting of the City Council of the City of Bay Minette was held on November 7, 2022, at 6:00 p.m. at the City Hall in Bay Minette, Alabama; this being the proper place, scheduled date and hour for holding such meeting.

On roll call, the following members of the Council were found to be present: Mayor Robert A. Mayor Wills called the meeting to order. Councilmember Taylor gave the invocation. Councilmember Sellers led the Pledge of Allegiance.
