The regular meeting of the City Council of the City of Bay Minette was held on February 20, 2024, at 6:00 p.m. at the City Hall in Bay Minette, Alabama; this being the proper place, scheduled date and hour for holding such a meeting.

On roll call, the following members of the Council were found to be present: Mayor Robert A. ## Consent Agenda
